

Dual Enrollment Test Waiver for 2024-2025 Academic Year

Due to COVID-19, ETSU is adjusting our admissions criteria for dual enrollment students to accommodate those students who may not meet the normal test requirements. This waiver is for use during to 2024-2025 academic year. Accuplacer may be needed for classes outside of the approved list. Please be advised that ACT/SAT scores are used to measure college readiness. By signing this waiver, you are agreeing to the statements below which outline some potential risks associated with taking a college class as a dual enrollment student without test scores as an indicator of college readiness.

- **Your grades will be on your high school and college transcripts. Therefore, a poor or failing grade could have unforeseen effects on your academic plans or could impact your ability to graduate high school. This grade will also be a part of your college transcript.**
- **You must maintain a dual enrollment GPA of at least 2.0 in order to keep the dual enrollment grant.**
- **You are responsible for following the ETSU guidelines and responsibilities while you are a dual enrollment students which include academic calendar dates for course changes or withdrawal.**
- **Dual Enrollment courses at ETSU are college courses that require the level of work expected from all ETSU students.**
- **Students using the waiver must choose classes from the approved list of classes as outlined by the Office of Admissions.**

Dual Enrollment Test Waiver Instructions and Course Options 2023-2024

Students with a 3.4 high school GPA can use the Dual Enrollment Test Waiver in lieu of submitting test scores for admittance

- 1) Students are required to submit: 1) online application, 2) dual enrollment authorization form, 3) test waiver, and 4) transcripts.
- 2) Students using the waiver must choose classes from the approved list of classes listed below. Classes not listed may be approved by the dual enrollment academic advisor as needed. The Accuplacer could be recommended in some cases.
- 3) Students will be allowed to continue in subsequent semesters after making a C (not C-) or higher in coursework taken under the waiver.
- 4) Students can use the waiver if they have a 3.4 high school GPA even with ineligible test scores.
- 5) All class pre-requisites also apply and are not replaced by this waiver.
