The East Tennessee State University – Clemmer College of Education has implemented a yearlong Residency program that places teacher candidates in the schools for an increased number of clinical hours in Residency. Candidates stay with the same mentor for Residency II, the traditional student teaching semester. The collection of data for the Residency year has been facilitated by the use of LiveText, a software program that tracks candidates, mentors, placements, and summative assessments. Residency Description: Pre-Residency Pre-Residency teacher candidates meet and work with their mentor teachers in partner school systems prior to Residency I. Pre-Residency includes a 50 hours field component and additional coursework. Residency I Residency I teacher candidates meet and work with their mentor teachers in partner schools prior to Residency II. Residency I candidates learn school and classroom demographics as well as policies while getting to know students and their academic curriculum needs. The number of hours in Residency I will vary by program. Residency II The Residency II semester must be a minimum of 15 full weeks of observation, teaching, and co-teaching. This semester must include a placement in at least two different settings. Residency II is 562.5 hours of clinical experience.

Teacher candidates enrolled in education preparation in the ETSU Clemmer College of Education participate in field experiences in a variety of settings (mostly urban and mostly rural) across northeast Tennessee as well as a year-long clinical residency in a public school setting. Our region is located in central Appalachia and includes several counties recognized by the Appalachian Regional Commission as distressed and are defined as counties that rank in the worst 10 percent of the nation in the areas of unemployment, per capita market income, and poverty rates. Our teacher candidates are required to pass the content exams required for state licensure prior to entering the year-long clinical residency where they take on the role of a co-teacher with a highly qualified and effective veteran mentor teacher. Teacher candidates are held to high standards and are judged on the Tennessee Educator Acceleration Model (TEAM). Tennessee became one of the first states to implement this comprehensive, student outcome based, state-wide educator evaluation system. In order to prepare teacher candidates to match the needs of Tennessee's schools, this tool (including rubrics across 18 domains) is incorporated into the assessment of our teacher candidates. The TEAM evaluation consists of frequent observations, use of student data, professional development, and constructive feedback for teachers across multiple classroom/teaching observations. Additionally, each teacher candidate completes the edTPA, a performance-based, subject-specific assessment to measure and support the skills, knowledge, and effectiveness that teachers must display in the classroom. The edTPA requires each teacher candidate to collect student performance data, display the data in the form of charts and graphs, analyze the data in detailed commentary which outlines steps to improve learning and teaching. Teacher candidates video record a series of learning segments as part of this evaluation and analyze their teaching to determine the impact on K-12 students as well as Teacher preparation programs in the Clemmer College of Education at ETSU integrate evidence-based instructional strategies and the academic standards adopted by the Tennessee State Board of Education. Throughout the fall of 2015, the Tennessee Standards Recommendation Committee solicited feedback from across the state through regional meetings and roundtable discussions with educators, parents, and the higher educational community which included many of the ETSU Clemmer College of Education faculty. New math and ELA standards will be implemented and assessed in 2017-2018. Courses throughout all teacher education programs in the Clemmer College of Education focus on differentiation of instruction to meet the individual needs of all students. Coursework and field experiences highlight the strategies for tailoring instruction to meeting individual needs through differentiation of academic content, process, products, and the learning environment. Research-based strategies for addressing the needs of English-language learners are embedded throughout the teacher education program. Candidates are expected to make use of ongoing assessment and flexible grouping in order to ensure success of all children. Additionally, all teacher candidates complete at least one course in the area of special education which provides a survey of various disabilities, focusing on history, legislation, diversity, causes, characteristics, educational strengths, interventions, assistive technology, assessment, and support services for individuals with disabilities and their families.

Prior to a year-long residency in the public school setting, teacher candidates have intensive, well-structured, and supervised field experiences in a variety of settings including rural schools that serve low-income and minority students. The Clemmer College of Education at ETSU offers 37 initial teacher education and other school service personnel preparation programs. These programs are approved by the Tennessee Department of Education and accreditation from the National Council for Accreditation of Teacher Education (NCATE). Our programs will undergo accreditation review by the Council of Accreditation for Education Preparation (CAEP) in 2020. The largest teacher education programs are elementary education (K-5) and early childhood education (PreK-3). These programs account for approximately 70% of teacher education graduates each year. The remaining 30% are prepared for other K-12 teaching areas including special education, science, math, English, social studies, art, history, chemistry, biology, physics, foreign languages (Spanish, French, and German), physical education, music, and technology. All teacher candidates complete the edTPA, a performance-based, subject-specific assessment that emphasizes and measures the skills and knowledge that an effective teacher demonstrates in the classroom. This assessment requires teacher candidates to demonstrate readiness to teach through lesson plans designed to support their students' strengths and needs; engage students in ambitious learning; analyze whether their students are learning, and adjust their instruction to become more effective.
