## Dear Loyal ETSU Supporters,

Academic and fiscal year 2016-17 has been a "Season of Change" for the ETSU Foundation and University Advancement and it has truly been a team effort. Among many other accomplishments during the year, we:

- Completed hiring to increase fundraisers from two to 11 and made key additions to central advancement to support and enhance fundraising efforts.
- Established new bylaws for the ETSU Foundation (www.etsu.edu/alumni/foundation).
- Welcomed a new Foundation Board of Directors (www.etsu.edu/alumni/foundation/directors.aspx).
- After lengthy review, the Board of Directors selected two investment firms to manage the endowment: Goldman Sachs and AGC of Atlanta. We are in the process of converting the funds now.
- Developed a new program of events and activities for ETSU supporters: the "President's Circle." You become a member of the circle by giving at least \$500 to ETSU during the calendar year. We are planning the following President's Circle events:



- o The Academy for the President's Circle. October 27, 2017 we will conduct an event to give the President's Circle members an opportunity to become students again. You will be able to select three courses held on campus to reacquaint yourself with fellow students and faculty. Please look for your invitation soon.
- o Football Pre-Game Activities held at the Wayne G. Basler Center of Physical Activity Courtyard near the stadium, to gather with President's Circle members. Meals catered by Firehouse restaurant will cost \$15 for adults and \$8 for children under 10. Foundation directors will also be on hand to help cheer the Bucs to victory! Home games are 9/2, 9/16, 9/23, 10/7, 10/28, and 11/4. Activities begin two hours before game time.


- **Major Giving** staff will attend "Developing Major Gifts" course, conducted on the ETSU campus August 15-17, led by Indiana University's Lilly Family School of Philanthropy.
- Andrew Amodei, Bus. & Tech., left the University in July; working to fill the position ASAP.
- **Advancement Services** hired a Technology Coordinator for report writing; Gift Processing position now open; contracted for campaign wealth screening and related services for FY18+; EFT donor numbers up significantly
- WETS-FM excellent year in fundraising! Listener support increased 63.5% (\$371.2K total).
- Annual Giving donations up 34%; total donors are up; social media presence coming soon.
- **Planned Giving** booked \$2.8M+ in planned/deferred gifts and \$150K in major gifts; nearly 5K website visitors during 2016-17; conducted 11 presentations and/or Legacy Circle events.
- **Alumni Assoc**. presented 7 awards; welcomed '67 class to Golden 50s; working on new football events; regional Alumni-club organizing is ongoing, with more alumni/student activities.
- Athletics excitement surrounding SoCon Champion men's BB team and the new on-campus FB stadium has fueled great passion/anticipation for this year; this was the second highest fundraising total in history of ETSU Athletics; while activity for the Excellence Fund, 1911 Legacy Wall, Letterwinner Lockers, and Family Trees grows. We are very grateful to our donors, season ticket holders, alumni, and fans.

Private Giving in the form of grants reached \$5.3M this year, matching the previous 3-year average. **This brings total recorded giving for 2016-17 to \$17.2M.** The chart below summarizes net production, philanthropic cash, and the Annual Fund but does not include grants.
