The ETSURA played an integral role in getting students checked into Governor's Hall. Overall, Move-in-day turned out to be a big success.

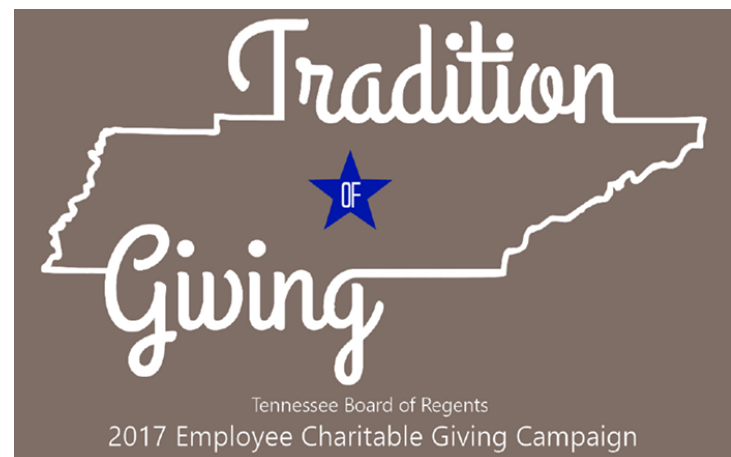

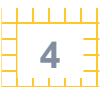
