As part of our office’s obligation to comply with the federal regulations, all international students who need to obtain a new I-20 or DS-2019 must show proof of sufficient funds to cover one full year of expenses at East Tennessee State University. Barring unforeseen circumstances, you should plan that adequate funding will be available from the same or equally dependable sources for all subsequent years. This is the standard that all consular officials use to determine visa eligibility. Your financial documentation may include a personal bank statement, scholarship offers, assistantship offer letters, or letters written by your sponsoring agency\*. The documentation must include explicit numerical balances and be dated with the 3 most current months.
