Jason Davis moved to approve minutes from the March 5, 2025 meeting. Allen Coates seconded. The motion passed.

New Business

- Revise Curriculum: Substantive - English Major, B.A.

Scott Honeycutt provided an overview of the revision to the minor which establishes a major core and creates three concentrations: English Teacher Education, Literary Studies, Creative Writing. The revision removes two courses and adds Southern Appalachian Literature and Environmental Literature as elective options.

Amy Malkus provided an overview of the proposed course which is designed to add Special Education content with the goal of meeting NAEYC and DEC standards. This course focuses on PreK-3rd grade and will be used in the undergraduate and graduate licensure programs.

Megan Krupa provided an overview of the revisions to the minor which 1) eliminates EDFN 3301 Issues in Education, EDFN 3310 Educational Psychology, CUAI 4416 Residency I: Middle and Secondary School Curriculum, Instructional Methods, and Assessment, CUAI 4426 Residency I: Secondary School Curriculum and Methodology Field Experience, READ 4557 Adolescent Literacy Assessment and Instruction, and COMM 4417 Teaching Secondary Speech and Theater; 2) adds CUAI 4418 K-12 or Secondary School Curriculum, Instructional Methods and Assessment and CUAI 4428 K-12 of Secondary School Curriculum and Methodology Field Experience; and 3) changes the name of the minor from Secondary Teacher Education Preparation to Teacher Education Multiple Disciplines.

John Wheeler provided an overview of the revision which reduce SPED 4710 Residency I in Special Education from 5 credits to 3 credits then increase free electives by 2 credits.

John Wheeler provided an overview of the revision which clarifies the licensure and non-licensure pathways within the final semester by adding Licensure Option: 12 credits (SPED 4580 Residency II Field Experience in Special Education and SPED 4581 Residency II Seminar in Special Education) and Non-Licensure Option: 12 credits of advisor approved electives.

-New Course: CSCI 3240 Computation and Complexity Theory

Chelsie Dubay provided an overview of the proposed course which is part of the effort to modernize the algorithms course sequence and meet an accreditation visit recommendation to increase focus on computer theory. This course introduces the theory of computation: automata and languages, computability theory, and complexity theory.

-New Course: CSCI 4647 Network Defense and Countermeasures

Chelsie Dubay provided an overview of the proposed course which provides comprehensive cybersecurity training in threat analysis, network protection, and incident response.

-New Course: CSCI 4757 Business Process Integration

Chelsie Dubay provided an overview of the proposed course which explores the concepts of the enterprise structure and organizational data, master data, transactional data, business scenarios and processes, and business processes integration points.

Primary Reviewers Allen Coates and Brad Edwards found the course proposals to be well written with no areas of concern. Evelyn Roach noted there were no graduate assignments entered for CSCI 4757 Business Process Integration; this does not impact approval at the UCC level, but it will impact approval at the Graduate Curriculum level.

Alan Stevens provided an overview of the revision to the course which modifies credit hours from 1 to 0-1. The 0-credit option is only for music majors.

-New Course: MUSC 1205 Symphonic Band

Alan Stevens provided an overview of the proposed course which creates a lower tier ensemble for any students who do not make the audition cut for Wind Ensemble or Concert Band.

-Revise Course: Substantive Modification: MUSC 1221 Choir

Alan Stevens provided an overview of the revision to the course which modifies credit hours from 1 to 0-1.

-Revise Course: Substantive Modification: MUSC 1251 Chorale

Alan Stevens provided an overview of the revision to the course which modifies credit hours from 1 to 0-1.

- New Course: MUSC 1405 Introduction to Aural Skills

Alan Stevens provided an overview of the course which is designed to address attrition issues and increase student success in the major by introducing aural skills prior to completing the three-semester aural skills sequence (Aural Skills I, II, and III). This course includes chromatic solfege, intervallic training, pitch matching exercises, and an introduction to basic harmonic progressions.

Alan Stevens provided an overview of the proposed course which is designed to fill a deficit in instrumental knowledge for the vocal/general music education students. This course provides an overview of instrumental materials for vocalists.

-Revise Course: Substantive Modification: MUSC 4580 Band Methods and Materials I Alan Stevens provided an overview of the proposed revision which combines two semesters of courses in band methods to a single course for instrumental/general music education majors. The revision includes changes to the course and transcript titles, credit hours, and catalog description.

-Revise Course: Substantive Modification: MUSC 4581 Orchestra Methods and Materials I Alan Stevens provided an overview of the proposed revision which combines two semesters of courses in orchestra methods to a single course for instrumental/general music education majors. Alan Stevens provided an overview of the proposed revision to the minor which 1) replaces MUSC 1100 Music Fundamentals with MUSC 1405 Introduction to Aural Skills, 2) increases upper division elective credits by 1, and 3) adds new band to list of ensemble options.

-Establish Minor - Music Composition

Alan Stevens provided an overview of the proposed 20 credit minor which incorporates 10 existing courses (22 credits) and 1 new course, MUSC 3961 Applied Composition Level III (2 credits). This minor will give students interested, but not majoring, in music composition an opportunity to engage in composition courses.

Christiana Keinath and Daniel Hedden, Primary Reviewers for Music Proposals Part 9, found the proposals to be well written with no areas of concern.

The current concentration requires students enroll in either MATH 4137 Introduction to Modern Algebra II or MATH 4227 Analysis II. This revision proposes these courses be replaced with MATH 4157 Introduction to Modern Geometry to give students a broader view of mathematics.

Brad Edwards provided an overview of the proposed revision which edits the credit hours to create additional flexibility for students and maximize their ability to pursue field experience opportunities. This proposal changes the course from 9 credits to 3-9 credits. The department also plans to offer the course in fall, spring, and summer semesters rather than only summer semester.
